

TAKATA CRISIS: GUADELOUPE REMAINS IN A STATE OF CRITICAL EMERGENCY



Mobilization Must Intensify in Guadeloupe

As part of the global recall campaign targeting defective airbags from supplier TAKATA, GSA reminds the public that 1,272 “potentially dangerous” Volkswagen vehicles are still circulating in Guadeloupe without having undergone the required safety procedure. These vehicles must be brought into the workshop as soon as possible to ensure driver and passenger safety.

Since the start of this campaign, GSA teams have been fully committed, demonstrating their ability to act quickly and effectively:

- ✓ 658 airbags replaced in January 2025
- ✓ 555 in February 2025

However, the momentum has dropped sharply:

- ⚠ **Only 100 vehicles serviced in March 2025**
- ⚠ **Just 64 in April**

This slowdown is concerning, especially given that each unreplaced airbag poses a real risk of serious, even fatal, injury in the event of an accident.

We are issuing an urgent call to all affected vehicle owners: please return to the workshop without delay.

About the Takata Recall Campaign

The global airbag recall campaign issued by supplier TAKATA affects numerous car manufacturers, including several Volkswagen models. TAKATA provided the automotive industry with defective airbags or inflators, which may become dangerous over time, especially in certain climatic conditions such as high heat and humidity.

If your vehicle is equipped with these airbags, they may pose an increased risk of serious or fatal injuries in the event of an accident. They must be replaced or repaired as soon as possible.

We urge all owners of affected Volkswagen vehicles to contact GSA immediately, whether their vehicle was purchased within the official network, imported independently, or relocated to Guadeloupe (e.g. as part of a move).

Registering your vehicle with GSA ensures a quick identification and allows us to secure your vehicle without delay.
